### Presidential Report 2014 – 2015

I have the pleasure to report on the activities of the Rotary Club of Hobart during its 90 years of service to the Hobart community and beyond through our support of Rotary International and the Rotary Foundation.

The Rotary year commenced with a flurry of activity to celebrate our 90<sup>th</sup> anniversary on the 29<sup>th</sup> July when we held a very successful high tea for ninety, 90 year olds. Rotarian Tanya Denison did a great job co-ordinating the day and arranging publicity.

On the  $2^{nd}$  August we celebrated the  $90^{th}$  anniversary of receiving our charter with a dinner at the Henry Jones Art Hotel.

At the commencement of the year I announced that in collaboration with President elect Kate the Club would adopt Literacy at home and away as our theme for the next two years. Although during the year no significant funds were expended on this project nor programs commenced a great deal of effort has been put into research and networking. We had a number of guest speakers on the subject and formed a partnership with the faculty of Education at the University of Tasmania, which has also involved the Tasmanian Department of Education.

In early August we celebrated another milestone when the Art Show committee organised a very successful 25<sup>th</sup> Annual Art Show raising \$24,265.

Sail Day in March this year was once again a major contributor to our fund raising effort as well as a great fellowship and networking occasion and made a profit of \$36,854.

The Magic Show for many years has been one of our three major fund-raisers and this year was no exception. I would very much like to thank PHF Greg Cooper who virtually single handed raises around \$20,000 each year.

The other regular fund raising effort and community service is breathalyser testing at both the Beer Fest and Taste of Tasmania.

Special mention should be made of the Directors and Committee Chairs who have been responsible for raising in excess of \$80,000 this year. Although this figure fell a little short of budget it was still a magnificent effort, I would particularly like to thank Mark Quinane, John Field, Stephen Porter and Kate Domeney for the leadership they provided for these fund raising projects.

Members again volunteered many hours to youth projects both within the club and for the district. Both RYDA and the Science and Engineering challenge were again very well supported. I thank Shaun Lennard and Terry Kay, respectively for their leadership of those projects.

Jason McKenzie and Bess Clark directed a number of youth activities including the hosting of Simon Vieljeuf and our incoming student for 2015/16 as well as our outgoing student Rosalie Bester. A special thank you to Simon's host families and those who are hosting Madeline Poulsen during 2015/16.

Our Club sponsored 4 candidates to attend RYLA during the year and we thank former Rotarian Trina D'Orazio for co-ordinating our participation. I am delighted with the progress being made with the Windeward Bound Leadership Challenge and the prospect of it becoming a district project.

We hosted a Group I meeting in October for the first time and our Club continues to be represented at Group 1 meetings.

We combined with the Rotary Club of Kingston to present a night at the cinema to raise funds for Polio Plus.

To mark the significance of the contributions to the WWI effort by Charter Members of our Club and the Centenary of ANZAC a special luncheon featuring those contributions and attendance by representatives of the Defence Forces was held prior to Anzac Day. It was a pleasure to lay a wreath on behalf of our Club at the Cenotaph on Anzac Day.

Progress on the Charity House has been slow since the concept was first announced but progress with our partners the RHHRF lately has seen positive progress towards a business plan.

Fellowship opportunities have been limited this year with the annual Christmas drinks at Past President Sue Hickey and Rotarian Peter Bull's home again the highlight.

Membership numbers have been maintained, 7 new members – 7 retirements/resignations.

During the year I was pleased to present Paul Harris Fellowships' awarded by the club to Past President Tim Short and Rotarian Stephen Porter.

Towards the end of the year our Club partnered with our patron Her Excellency Professor the Honourable Kate Warner AM, Governor of Tasmania, to sponsor an essay competition marking the 800<sup>th</sup> anniversary of the sealing of the Magna Carta.

#### **COMMITTEE REPORTS**

#### 1. ADMINISTRATION & MANAGEMENT

#### **Director – Kate Domeney**

#### **Club History/Rotary Information**

A major effort to update our Club history in time for our 90<sup>th</sup> birthday celebrations was undertaken by PP Sue Hickey, assisted by Marcus Badcock. Our thanks go to both.

#### **Front Table**

The front table continues to organise us all cheerfully and seamlessly on a weekly basis – making sure we all pay our dues and greeting us with good humour and a friendly quip.

Guest Speakers Chair – Sue Hickey

During 2014/15 the Club met on 50 occasions and guest speakers were provided for 40 of the meetings. A guest speaker program was not provided for the Christmas dinner in December nor the change-over meeting in June. Speakers were not provided on eight occasions, designated by the President for fellowship. Speakers were sourced from the Club, from Rotary and the community.

Five club members provided behind the badge presentations.

Thank you to Past President Renzo for all the work he does in putting together the membership booklet, it takes a great deal of patience and effort.

#### 2. FUNDING

#### **Director – Stephen Porter**

This year \$82k\* was donated to 30 causes, 19 were for \$2000 or less. We approved an average of 3 requests each month, with 3 months having no approvals, and declined about 12 requests.

Major donations included \$10k each to Vanuatu and Nepal disaster relief work, \$10.5k to Rotary Foundation, Interplast \$5k, and Hobart City Mission -small steps \$5k.

Local vs International causes support ratio saw about a 54% local allocation \*.

Specific Literacy projects received around \$20k including Goodwood School, Reading, Writing and Riding and Clemente education programs.

A project to pay \$4000 for special equipment for the RHH Maternity Unit was approved after an emotional appeal by Merv Reid but, despite a couple of follow-ups, the money has not subsequently been sought by Merv or paid that I know of.

The Committee has been relatively stable in membership (7), retired members have been able to be more constant in their input but even those with full-time jobs have been participative as required (Mary Dwyer sends emails from all parts of the globe). Geoff Clark

had health issues around Christmas time and had to step down as Chairman, I took on the role until Brian Gallagher was appointed to the position in May.

During the year the committee raised the purpose of their role and funding limits with concern around duplication of effort and Board decisions on funding matters. The Board agreed to raise the committee's funding limit to \$2000 and to ensure all 'usual' requests get put through the committee. Requests handled by the Board and decisions made will be taken back to the Chair by me.

### 3. FUNDRAISING

**Director - Mark Quinane** 

**Breath Testing:** 

**Chair – Graeme Gourlay** 

The Rotary Club of Hobart again partnered with the State Government's Community Roads Safety Partnerships program and with event organisers to provide precautionary breath testing services at both the Beerfest in November and the Taste of Tasmania Festival over the Christmas / New Year period.

The rationale of providing a precautionary breath testing service is of itself a community service. If we can persuade just one person to decide to not drive a car if their blood alcohol reading suggests they should not, then we have fulfilled that community service to the highest degree possible. That we might also achieve that outcome whilst enjoying great fellowship is a bonus for those of our members undertaking that service.

It is the case that in the performance of this community service there also exists the opportunity to raise some funds by way of voluntary contributions in return for the breath testing services. This year we raised just over \$5,000 from both events and in so doing received some most appreciative feedback from the State Government's Road Safety Office.

Art Show: Chair - Stephen Porter

The first Rotary Club of Hobart Art Show was held in 1990 making the 2014 Show the 25th consecutive event. As in prior years, the event was designed to -

- Showcase the works of our local artists both established 'named' artists and emerging artists
- Provide an opportunity for sponsors to gain recognition for their business as a community and arts supporter
- Raise funds for the club to use in its ongoing community work

The Art Show forms an important part of our club's activity (it is one of our main annual fund raisers) and relies on many parties for its success. The parties include venue hosts, our many sponsors, external volunteers, our club members working at the Show and a dedicated committee.

Building on last year's enhancements, we again utilised the Wellington Room as well as the Boardwalk Gallery in the Convention Centre at Wrest Point. In addition to the paintings on show, we featured a collection of sculpture, furniture, 3D pieces, glass and hand-crafted items, metal sculptures, wood sculpture, contemporary brushed steel wall pieces, and leadlight mirrors. Jewellery and leather items, including fine hand-made handbags, were a popular feature again this year.

With 560 works, space is now at a premium, and we are well aware of the need to hang all works to optimise each work's presentation. We will work with our venue next year and may have to introduce a limit to the number of works we accept. Artists will be encouraged to register early and avoid missing our cut off as we will need time to plan space requirement for each category.

Our opening night was again a popular event with 260 guests enjoying food and wine, award presentations, as well as the auction. The opening night, a ticketed event, allows these patrons the first opportunity to view and purchase the works on display as well as mix with fellow artists, sponsors and Rotarians and guests.

Many thanks are owed to the people who provided items for our auction. Paintings, jewellery, a clothing voucher and an exclusive resort accommodation night away, raised almost \$8000 and contributed to our finances and provided great publicity and interest. Our thanks go to Max Angus, Joan Humble, Patricia Giles, Tom Samek, Anne Langman, Scott Breward, Gazman and Saffire Resort.

We are grateful to guest auctioneer, Neville Moane and Christine Moane , who ran the auction and successfully sold all items. I am pleased to advise that we now have both Neville and Christine as members of our Club.

Sponsorship is a vital part of our event, and we are grateful to the twenty six local businesses and people who helped in many ways to make the 2014 Show a great success. Their financial support is a vital part of our fundraising and we are very happy to provide publicity and promotion for them in return. Next year we will have an opportunity for a Naming Rights – Platinum Sponsorship for one business, and are open to start discussions now! The RACT took up a Diamond sponsorship this year, their first involvement with us, and we enjoyed them participating in the Opening Night and drawing Raffles on Sunday. Importantly, they offered the opportunity to have some of the unsold works shown in the Wilderness Gallery at their Cradle Mountain Resort.

Wrest Point, our Event sponsor, has provided tremendous support as our location host for several years. The extra time and resource they provide, plus their sponsorship support, are key factors in the Show's financial viability. We thank them again for working with us. Co-Op Toyota was our Gold sponsor this year, and this local family-owned business has become a regular sponsor in recent years.

Fourteen other sponsors took up Category sponsorships. Many sponsors have been with us for a long time and enjoy sponsoring a particular category, we welcomed 6 new sponsors some of whom have already indicated their intention to return next year given their delight in the show's offering.

We are delighted to provide recognition for all of our sponsors in our publicity both on-site in our event marketing, and in our external advertising and PR.

Additionally, we had in-kind support from a number of people and organisations, and again, this is greatly appreciated. We acknowledge and appreciate that sponsors generally support the Show for altruistic reasons, to help artists and the good work Rotary does in the community, rather than for a specific return.

Sail Day: Chair: John Field

This year's sail day was held in March 2015 rather than February, principally for two reasons. First, the bi-annual wooden boat festival was held in February and second, it was generally agreed that March's weather is a little more reliable than that encountered in February. So with a new date set, it was up to Norm Deane to summon the weather gods for favourable sailing conditions. As usual, Norm delivered and some 50 boats and in the vicinity of 500 participants sailed down the Derwent with Conningham as their destination.

The Carlton Surf Lifesaving Club again participated with two rubber duckies and four life guards, to enhance guest safety. We again welcomed the Coastguard to the fleet whilst keyboard king, Robert Brand again provided song sheets and music, which continues to be a much enjoyed feature of the day. This year for the first time Robert was joined by our newly emerging musician, Mike Walpole who displayed more than passable dexterity on the ukulele. We must also acknowledge the input provided by MAST and the participating yacht clubs as we strive to heighten awareness of safety on the water. MAST provided safety briefings and checklists for each participating vessel. The importance of MAST's involvement cannot be underestimated and we look forward to their involvement again in 2016.

Sail Day generated around \$35,000, and made a welcome addition to Club funds. This brings the total raised by Sail Day since its inception to an estimated \$800,000. This year's result reflects the generosity of our provisioning sponsors, St Ann's, Cascade, and Coca Cola, and the in-kind sponsorship of The Mercury, Southern Cross Television, the Tasmanian Wine Centre and Co Op Toyota. We are grateful to all of them and to the number of smaller sponsors for their support, without which Sail Day would not be such a great success.

The Sail Day committee again applied their customary hard work and persistence in the face of a difficult economy.

Magic Show: Chair: Greg Cooper

Each year for the past 20+ years the Hobart Rotary club is the host for a major fundraising opportunity through International Entertainment and its nationally touring "Magic Show" This project requires the use of Telemarketers to canvass support from the business sector to purchase tickets to the Magic Show. These tickets are then "donated" to community welfare groups and 1500+ disadvantaged children in Southern Tasmania along with their parents and or support team to attend the Magic Show which is a great experience for many of them. In addition 20% of the sale proceeds then are allocated to the Hobart Rotary club and we allocate those funds to further worthy programs, with again, the focus being on disadvantaged youth, such as the proposed Windeward Bound programs that we have undertaken.

As the project involves the use of Telemarketers, under Rotary guidelines we require the approval of the District Governor prior to that occurring.

The 2013 Magic Show again raised in the order of \$17,000.

### **Rotary Youth Driver Awareness (RYDA):**

The program for the Hobart region was again held at the Royal Hobart Show grounds from Friday August 22 to Thursday September 11 2104

2,600 year 10 students from 32 schools attended this year.

90 volunteer positions were required and the Hobart club supplied 18.

The young people are made aware of car stopping distances by observing and being passengers in a car stopping in an emergency mode stop. The Police department warn the children on many facets of being in charge of a potentially killing machine. Talks are given by persons who have survived horrific accidents which have left them disabled. Lectures are given on being aware of other drivers and pedestrians at all times, and the effect of drugs and alcohol will have on their driving performance.

A big thank you to Norm Deane, Dugald McDougal, Heather Chong, Geoff Squib, Don Scott, Chris Carrick, Claudette Wells, Peter Murfett, Ian Shuey, Helen Mitev, Ian Cannon, Bill Casimaty, and Graham Gourlay. Some volunteers performed more than one all day shift.

#### 5. COMMUNITY & INTERNATIONAL SERVICE

**Director - Cecile McKeown** 

#### **General Comments**

**The Community and International Service Projects** portfolio of the Rotary Club of Hobart is comprised of a number of Committees: Bowelscan; Community Service Projects; International Service Projects; RAWCs; RYLA and Vocational.

The following are highlights from the activities of the 2014-15 year for inclusion in the Club's Annual Report:

#### **International Service:**

The Board donated \$10000 to Shelter Box in response to the Nepal Earthquake. The Committee has explored a number of options for future projects following on from the successful Fiji Project of the 2013-14 Rotary year. A proposed program for Cambodia reached a good stage of planning but was unable to be progressed in this Rotary year. Other suggested projects are still under investigation.

#### **Community Service Projects**

Planning has been undertaken to restore Rotary Plaques in Queens Park. While progress has been delayed, we now have a definite way ahead for an assessment of what is needed with work anticipated to begin in the 2015-16 Rotary Year.

Discussion has occurred with the Hobart City Council re restoring the Rotary Clock in Wellington Court to good working order. Assessment of the needs will be undertaken by a Council member with report back to the Club as to what is needed and the likely cost. Monies left by a Probus Club of over \$600 to the Rotary Club of Hobart will help to refurbish the clock.

#### **BOWELSCAN:**

The Bowelscan program has not been active during the 2014-15 year at District and local level. Earlier kits have been found difficult to use. The program will be reactivated in the 2015-16 year at District and Club level with a redesign of kits that are easier to use and provide more accurate results.

#### **Vocational:**

A successful Vocational Visit was undertaken to NYSTAR. An information session on the history of NYSTAR commenced the visit. The relationship of NYSTAR to the city of Hobart was also covered. Important safety procedures were also outlined and discussed.

#### Rotary Australia World Community Service (RAWCS):

RAWCS work continues in the 'background' in support of international projects and related Rotary work at District and Club level.

#### **Rotary Youth Leadership Awards (RYLA):**

Chair - Catriona D'Orazio

The 2015 RYLA camp at Camp Clayton was once again a great success with the Board committing to the sponsorship of four candidates for 2015 at the total cost of approximately \$4000. Due to illness and unforeseen circumstances, only three RCH candidates were able to attend the camp. A number of RYLA attendees presented to the Club's lunchtime meeting in June on their experiences and what RYLA has come to mean to them. RYLA continues to have a very positive impact on the lives of young people who attend Camp Clayton. At a District level, the RCH Chair of RYLA acted as a contact point for Clubs and for candidates from the South.

### iRYLA (International RYLA):

Natalie Jones, sponsored to attend iRYLA (part of the Rotary International Convention week) made a presentation to the club members on September 2 Meeting as to the great impact that attendance had made on her life.

#### 6. AWARDS:


Congratulations on being awarded (jointly) the District Trophy for all round Rotary Foundation support and activity.
